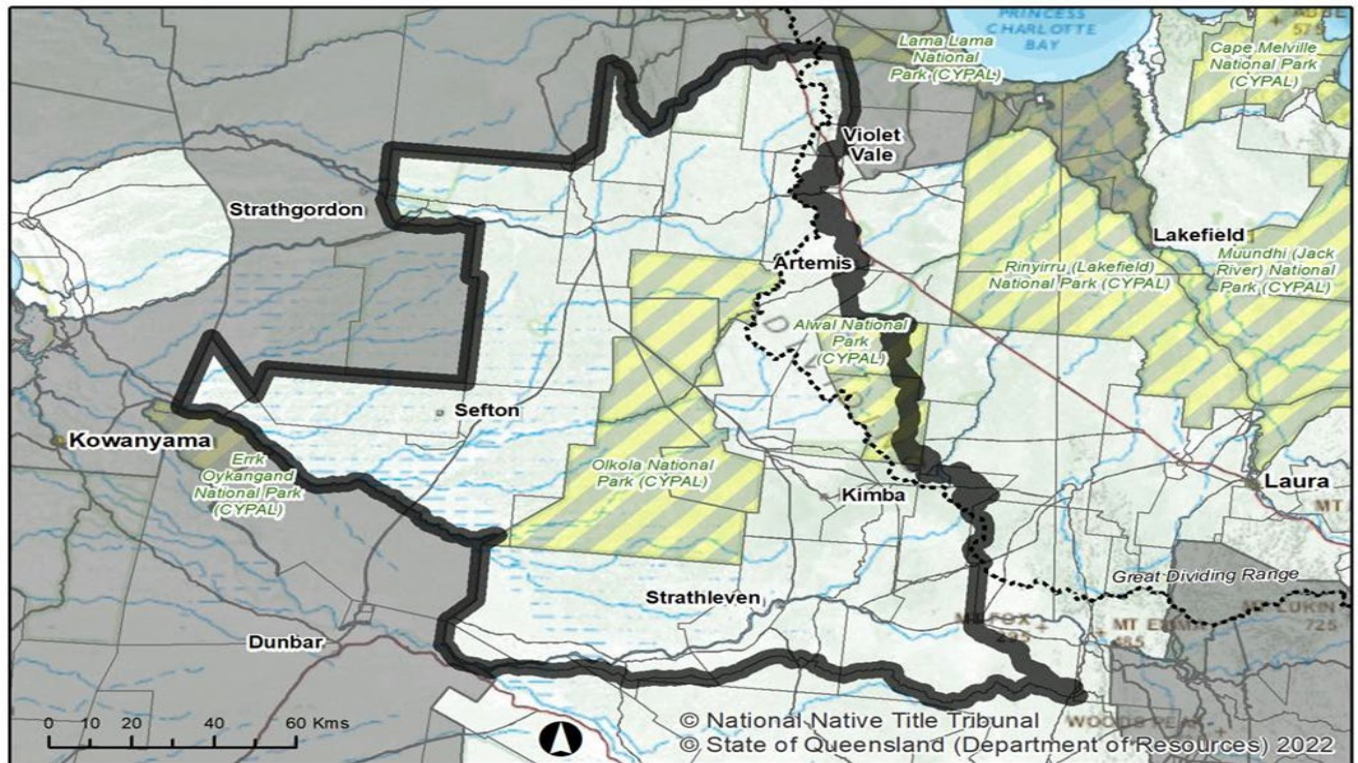

Purpose of Meeting and Attendance

The purpose of these meetings is for the groups to meet with their neighbours and make decisions about common boundaries. These are important meetings and CYLC will take instructions about this boundary decision by way of written resolution. The boundary description must be provided to the State of Queensland under the Federal Court timetable. The boundary negotiated during this meeting will form part of the final administrative boundary of each native title group's Prescribed Body Corporate (PBC).

These meetings form part of the boundary identification, negotiation and mediation plan for Olkola, Kunjen Olkol and Kowanyama People (Kowanyama Kunjen) People Native Title Groups. The notices have been sent to those persons who have been nominated by their respective groups as people with traditional knowledge about boundary areas and the cultural authority to make decisions about those areas. It is very important that those people attend the meetings in the week of 11 September 2023.
