NOTICE OF MEETING FOR THE EASTERN KUKU YALANJI NATIVE TITLE GROUP

Cape York United # 1 Native Title Claim (QUD673/2014)

21 AUGUST 2024

YARRABAH

This notice is to advise that Cape York Land Council (CYLC) will be facilitating a meeting on **Wednesday 21 August 2024** in Yarrabah for all members of the Eastern Kuku Yalanji Native Title Group in relation to the Cape York United #1 Claim (CYU#1 Claim) and proposed native title determination over the area shown on the map **below**. Please note the boundary between Eastern Kuku Yalanji and Western Yalanji within the area shown has not yet been finalised. This meeting is being renotified due to unavailability of the Independent Genealogist for the meeting on 12 August 2024.

This is a further meeting to discuss the progress of the CYU#1 Claim, and in particular the group description of the Eastern Kuku Yalanji Native Title Group. The first meeting was held in Cairns. This meeting is to be held in Yarrabah for those residents of the community and surrounding areas who were not able to travel to the meeting in Cairns. CYLC will not be providing travel assistance for this meeting.

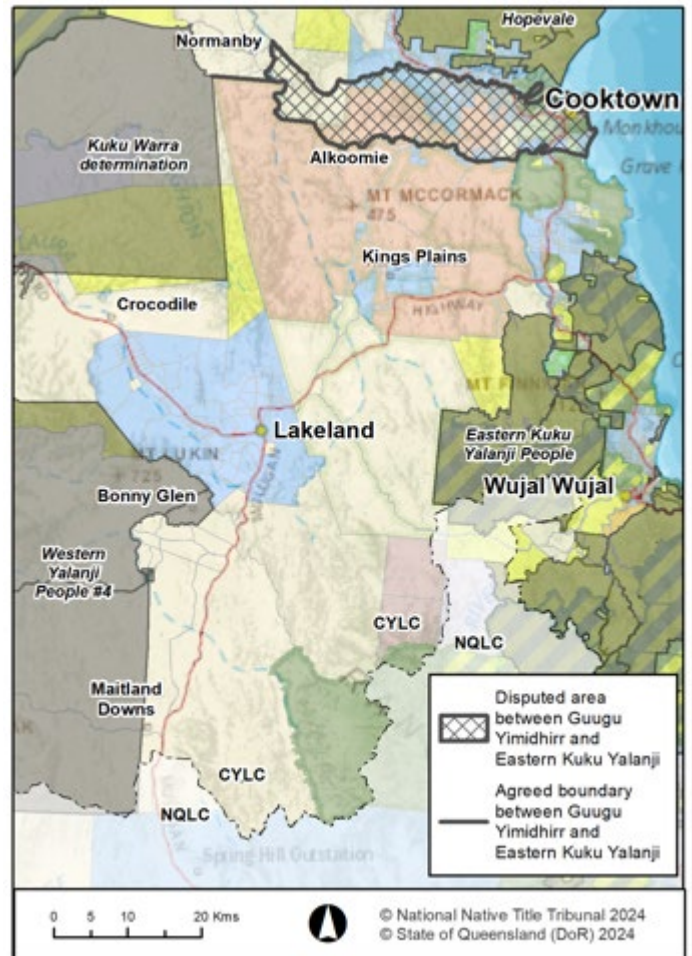

Purpose of Meeting

This meeting is a further meeting following the group description meeting in Cairns on 16 and 17 July 2024. This meeting is taking place in Yarrabah to provide opportunity for discussion about group description to Eastern Kuku Yalanji People who were not able to travel from Yarrabah or surrounding areas to the meeting on 16 and 17 July 2024.

The purpose of this meeting is for the legal representative of the Applicant in the CYU#1 Claim to provide information to the Eastern Kuku Yalanji Native Title Group about the following matters:

1. The progress towards determination of the area associated with the Eastern Kuku Yalanji Native Title Group towards a consent determination in May 2025; and
2. The draft native title group description, by descent from listed apical ancestors, for the Eastern Kuku Yalanji Native Title Group.



The legal representative of the Applicant will be seeking feedback on the draft native title group description. The Independent Genealogist (Family Tree expert) will be present at the meeting and will have availability to meet with family members as requested.

There will be a further meeting in October 2024 where the Eastern Kuku Yalanji Native Title Group will be asked to make a decision about the apical ancestors for the Eastern Kuku Yalanji Native Title Group.

Who is invited to attend the meeting?

All members of the Eastern Kuku Yalanji Native Title Group residing in Yarrabah and the surrounding areas are invited to attend the meeting.
