Eastern Kuku Yalanji Native Title Determination (QUD 6008 of 1998)

Cape York United #1 Native Title Claim (QUD673/2014)

On 8 May 2024, the Department of Resources issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying that the proposed Exploration Permit for Minerals (**EPM**) 28595 is an act that attracts the expedited procedure.

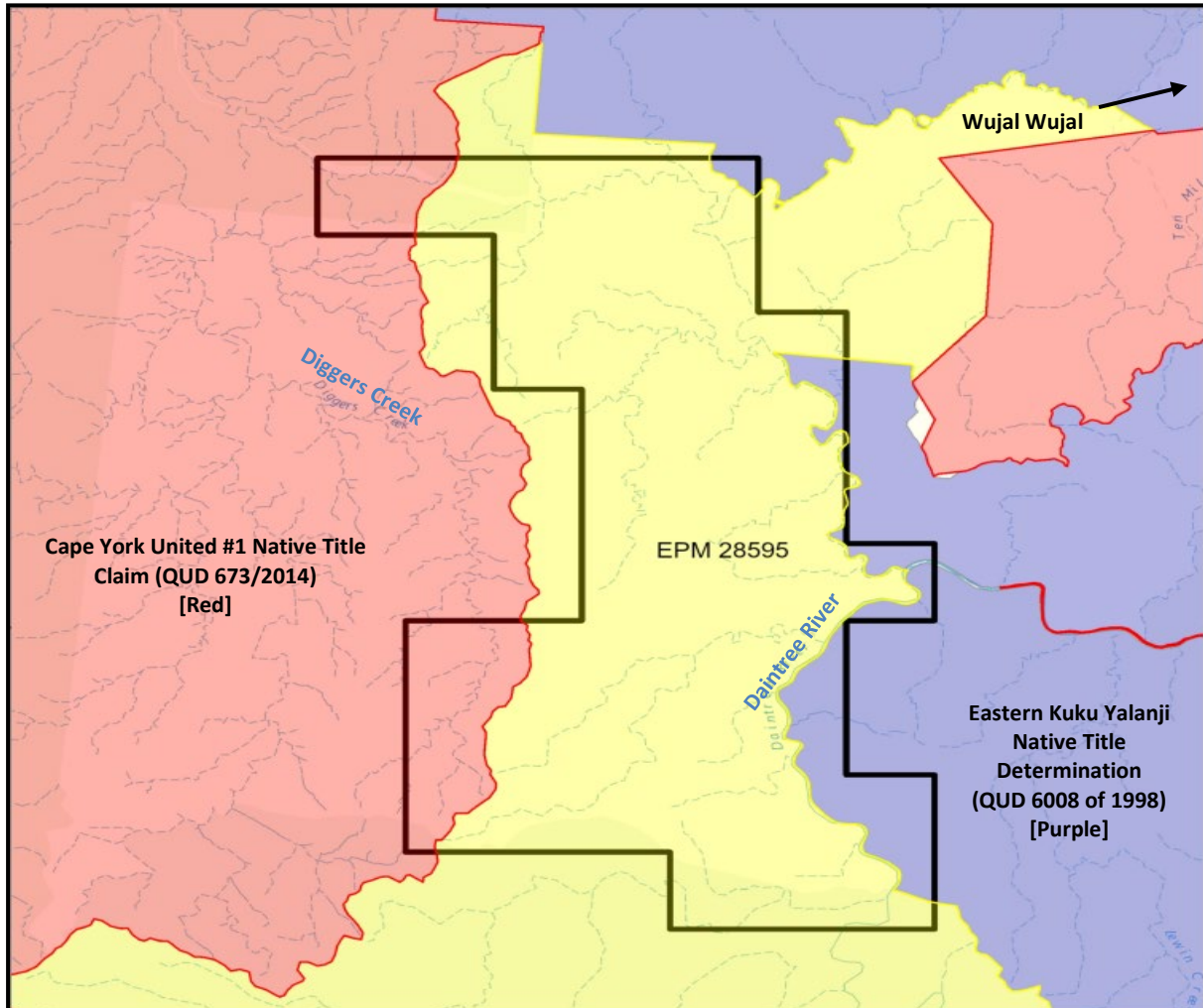
This notice is to advise that Cape York Land Council (**CYLC**) will facilitate a meeting with:
