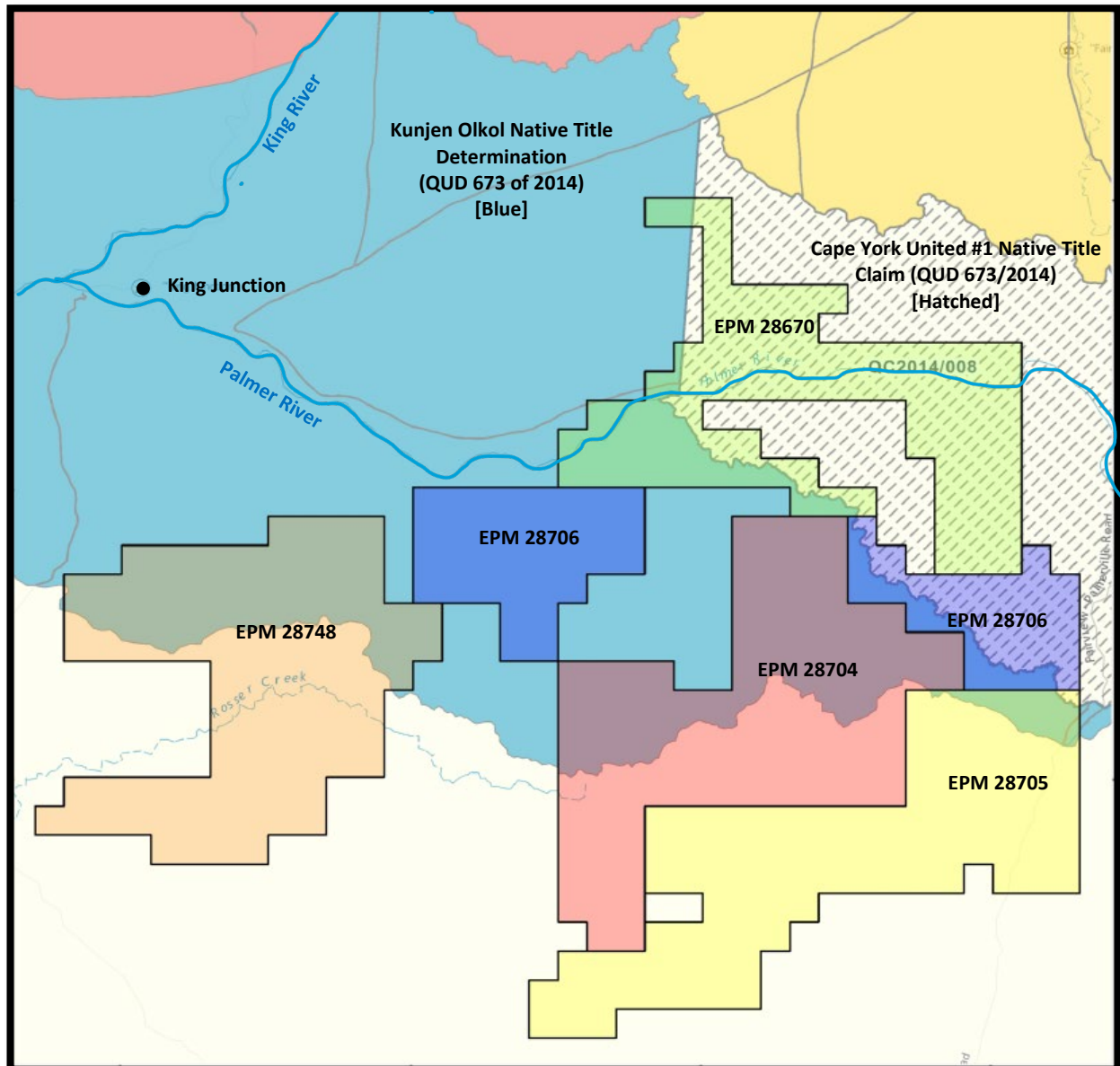
The Explorer has commenced full enquiry proceedings with the National Native Title Tribunal (NNTT) with a view to receiving a determination that expedited procedure applies to EPMs 28670, 28704, 28705, 28706 and 28748.

At this meeting CYLC will discuss with the Native Title Party the NNTT's full enquiry process and the options available to progress this matter.
