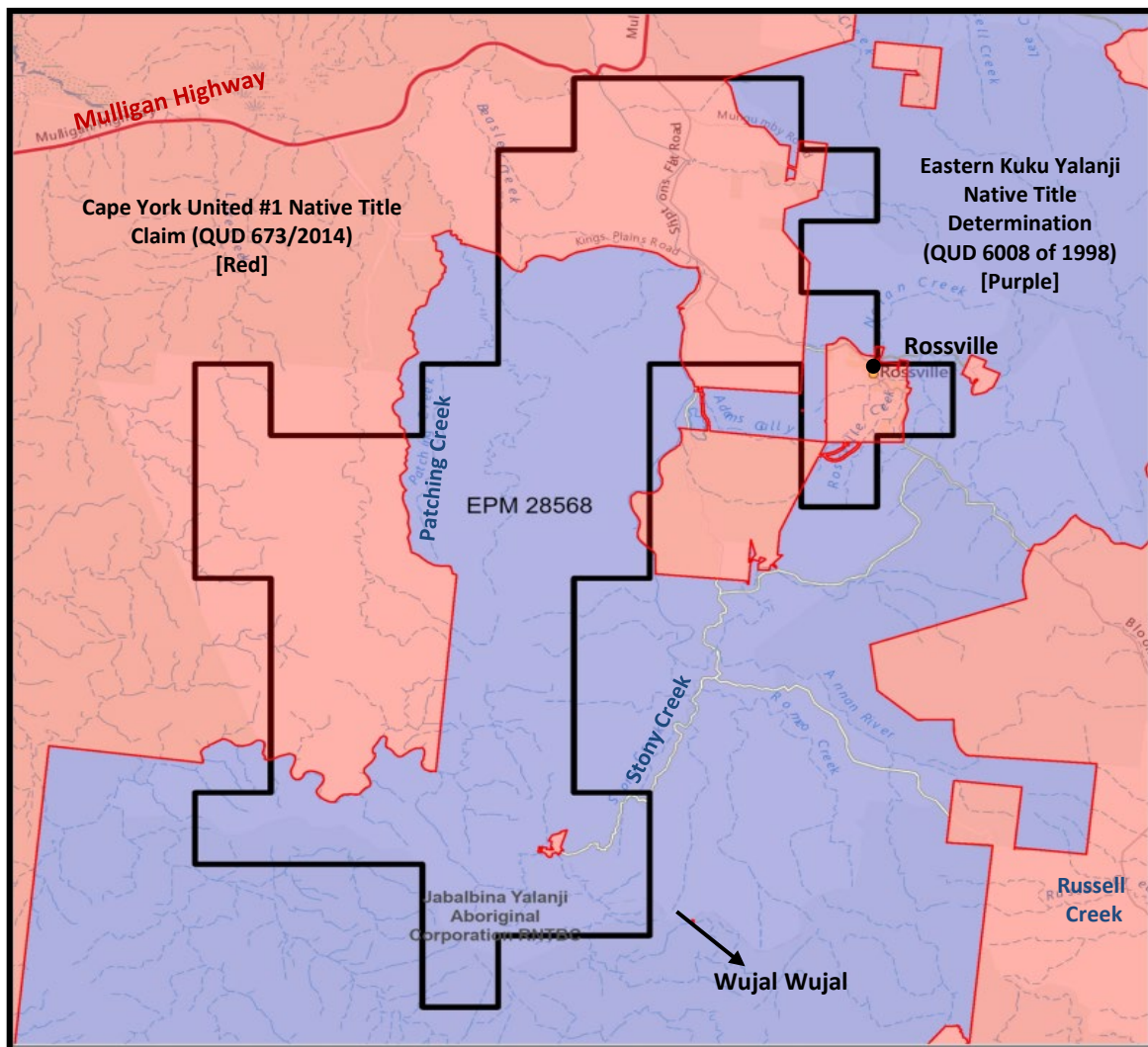
On 8 May 2024, the Department of Resources issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (NTA) identifying that the proposed Exploration Permit for Minerals (EPM) 28568 is an act that attracts the expedited procedure.
