Eastern Kuku Yalanji Native Title Determination (QUD 6008 of 1998)

Cape York United #1 Native Title Claim (QUD673/2014)

On 8 May 2024, the Department of Resources issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying that the proposed Exploration Permit for Minerals (**EPM**) 28568 is an act that attracts the expedited procedure.

This notice is to advise that Cape York Land Council (**CYLC**) will facilitate a meeting with:

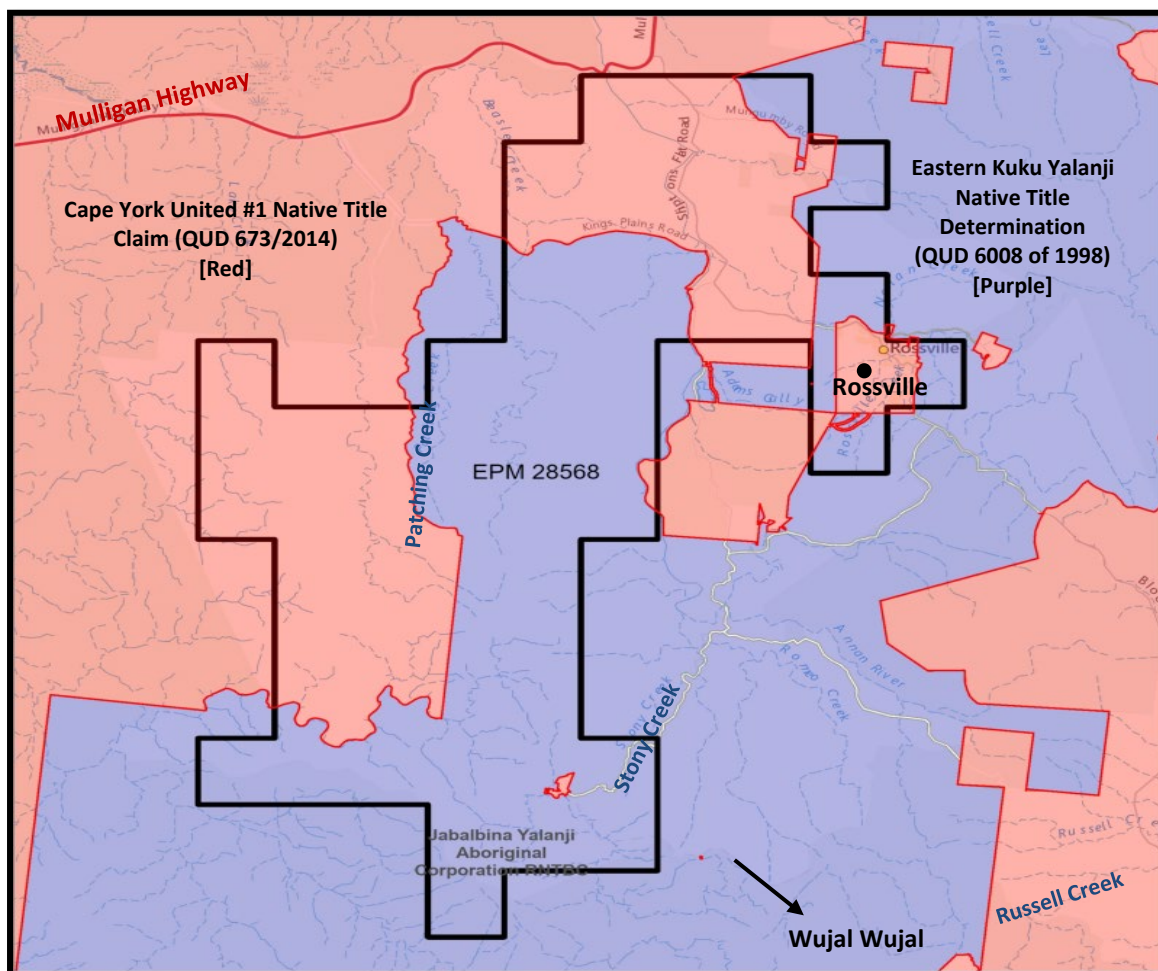
1. those people who hold Native Title rights and interests within the Eastern Kuku Yalanji Native Title Determination (QUD 6008 of 1998) within the proposed grant of EPM 28568 (as shown on the map below in **purple**); and
2. those people hold or may hold Native Title rights and interests within the Cape York United #1 Native Title Claim (QUD673/2014) within the proposed grant of EPM 28568 (as shown on the map below in **red**).

CYLC will facilitate a meeting on 13 June 2025 to discuss the proposed exploration project with Traditional Owners who hold or may hold native title interests in the EPM area. This meeting is for Traditional Owners with interest in both the CYU#1 area and the Eastern Kuku Yalanji Native Title Determination area.

- options available to progress this matter under the *Native Title Act 1993* (Cth) and the *Aboriginal Cultural Heritage Act 2003* (Qld).

The terms of a proposed cultural heritage agreement for the EPM area will be discussed with those people whose Native Title interests may be affected by the proposed exploration permit.
