What is the purpose of this meeting?

The purpose of this meeting is:

1. To further **CONSIDER**, and if appropriate **CONFIRM** a number of additional apical ancestors for inclusion in the draft group description for the Eastern Kuku Yalanji Native Title Group; and
2. for the legal representatives of the CYU#1 Applicant to provide an **UPDATE** and **DISCUSS** the next steps required to progress towards a determination of native title for the Eastern Kuku Yalanji Native Title Group.

Who may attend this meeting?

All members of the Eastern Kuku Yalanji Native Title Group are eligible and invited to attend this meeting. As this is an important decision-making meeting, all members of the Eastern Kuku Yalanji Native Title Group are strongly encouraged to attend. The CYU#1 Expert Genealogist **Kate Waters** will present on the apical ancestors and will also have availability to meet with families on request.

The legal representatives of the CYU#1 Applicant will take instructions on the group description for Eastern Kuku Yalanji by way of resolution. In accordance with the applicable Federal Court timetable, the group and boundary descriptions must be decided by the Eastern Kuku Yalanji group and provided to the State for final agreement. If required, there will be a further meeting of the Eastern Kuku Yalanji Native Title Group where the group will be asked to consider any remaining apical ancestors to be included in the group description. CYLC will notify in due course.
