- Mining Lease (ML) 3010 (as shown on the map below in blue).

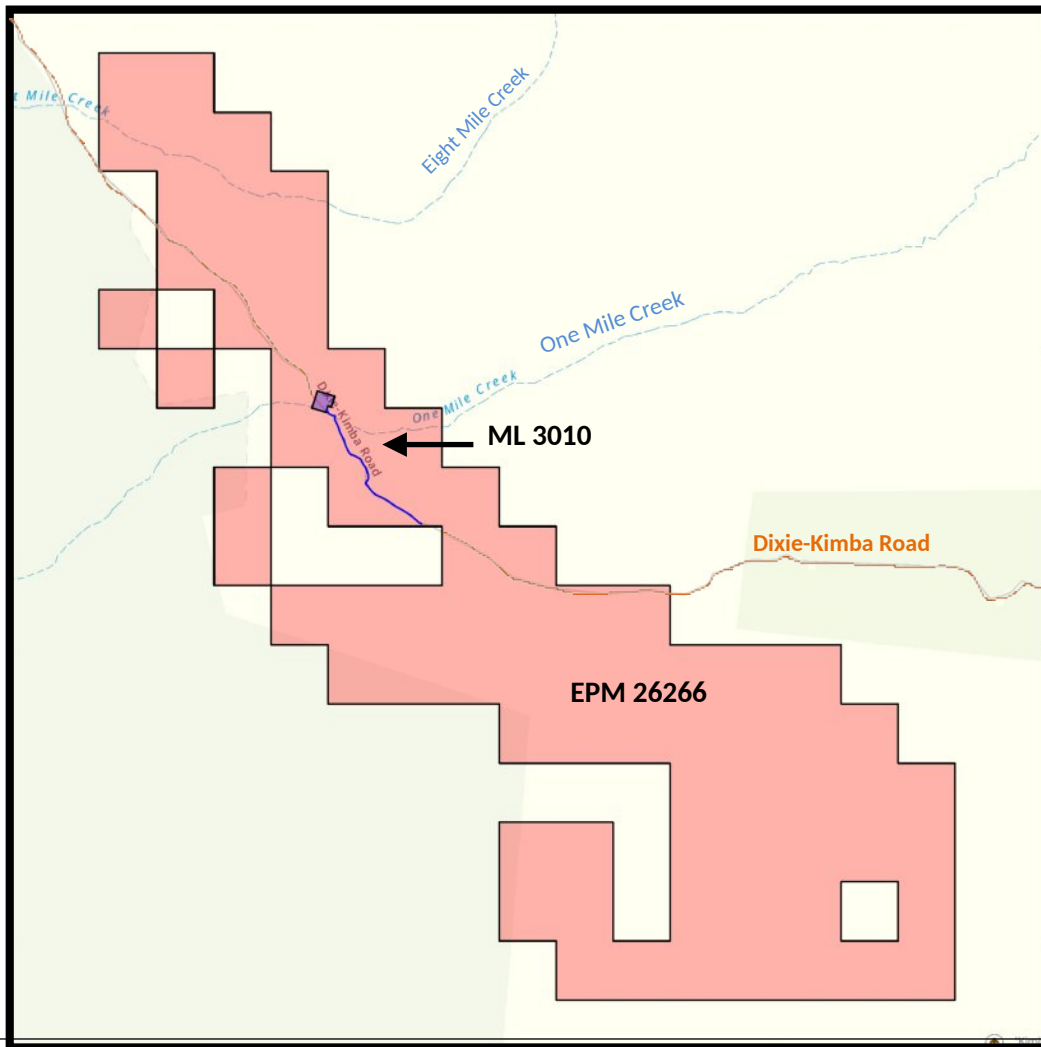
