EPM 28947 – EPM 29022

Kunjen Olkol Native Title Determination (QUD 673 of 2014)

On 12 March 2025, the State of Queensland issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (NTA) identifying that proposed Exploration Permits for Minerals (EPMs) 28947 and 29022 are acts attracting the expedited procedure.

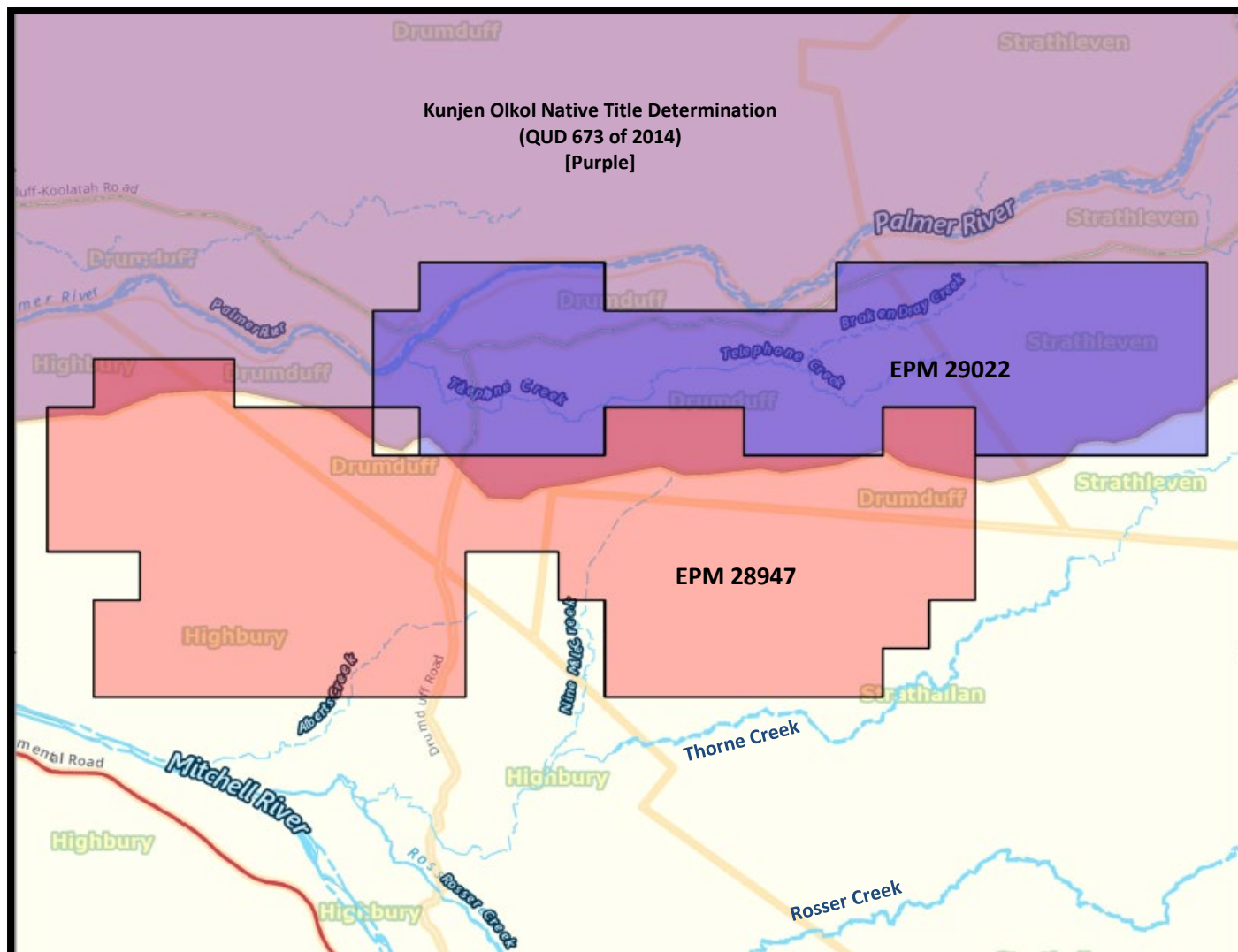
