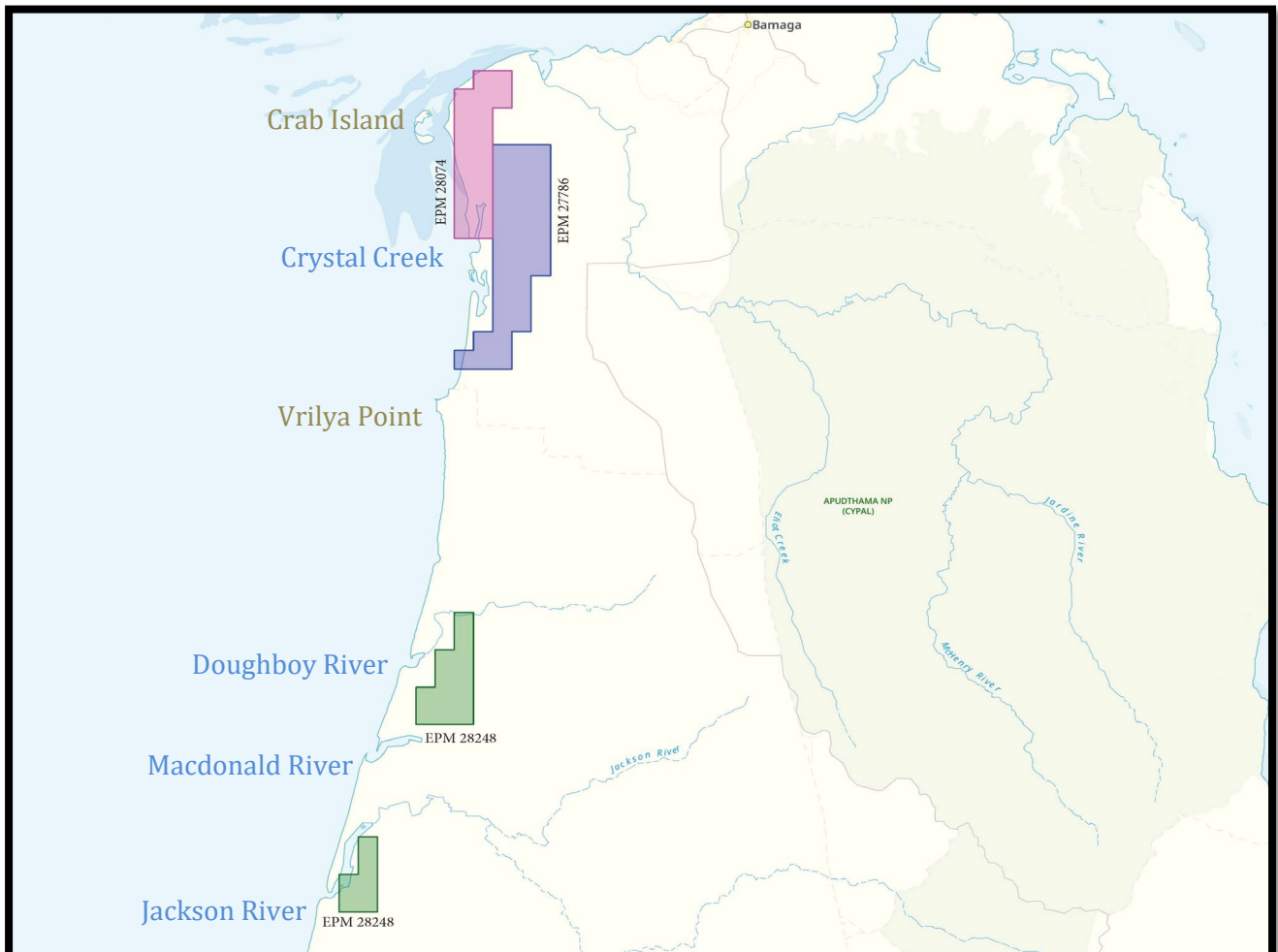
- 28074 held by Silica Australia Pty Ltd (below in pink);

EPMs 28074, 28242 and 27786 are under the normal negotiation procedure under s. 31 of the *Native Title Act 1993* (Cth) (NTA). At this meeting, CYLC will table the proposed ancillary agreement for this matter and seek the affected Native Title Holders feedback on the proposed terms of this agreement.
