Olkola Determination (QUD 673 of 2014)

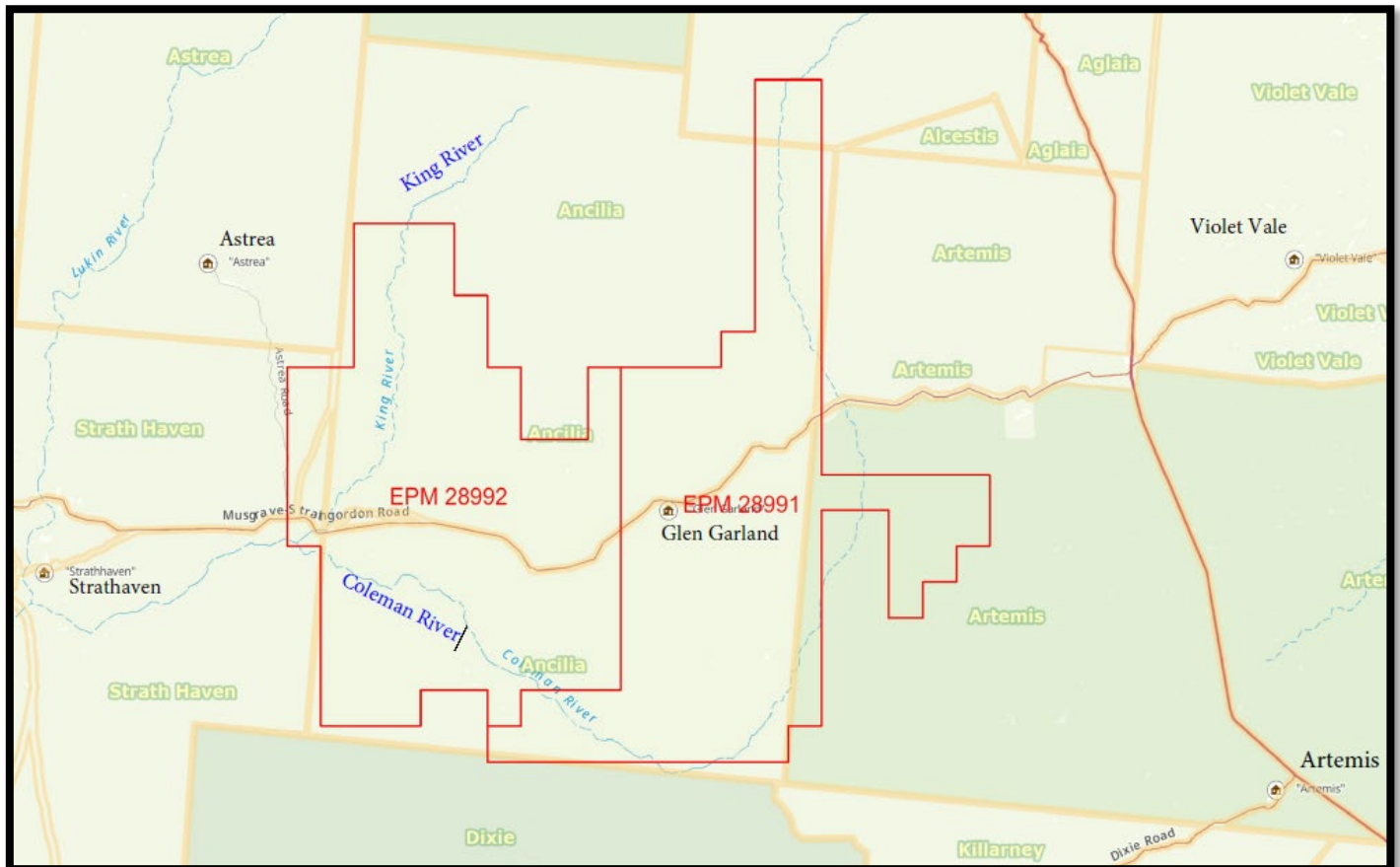
On 12 June 2025, the State of Queensland issued a notification under s.29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying Exploration Permits for Minerals (**EPMs**) 28991 and 28992 as acts attracting the expedited procedure.

This notice is to advise that Cape York Land Council (**CYLC**) will be facilitating a consultation meeting for those Native Title Holders who hold rights and interests in the area of EPMs 28991 and 28992 (as shown on the map **below**) within the Ut-Alkar AC RNTBC area. At this meeting, CYLC will discuss the expedited procedure and options available to progress this matter.
