# NOTICE OF CONSULTATION EPM 28702 – EPM 28913

Kunjen Olkol Native Title Determination (QUD 673 of 2014)

The State of Queensland has issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying that proposed Exploration Permits for Minerals (**EPMs**) 28702 and 28913 are acts attracting the expedited procedure.

This notice is to advise that Cape York Land Council (**CYLC**) will facilitate a meeting with those people who hold Native Title rights and interests within the Kunjen Olkol Native Title Determination (QUD 673 of 2014) subject to the proposed grant of:

- 1. EPM 28072 held by Palmer Gold NQ Pty Ltd (as shown on the map below in red); and
- 2. EPM 28913 held by GDM Cape Pty Ltd (as shown on the map below in blue).


