EPM 27606 and 27616 – TATE TRANSITION METALS LTD


Kunjen Olkol Determination (QUD 673 of 2014)

This notice is to advise that the consultation facilitated by Tate Transition Metals Ltd for people who hold Native Title rights and interests in the area of Exploration Permits for Minerals (EPM) 27606 and 27616 (as shown on the map below) **has been postponed and will be renotified**. On 10 November 2025 Tate Transition Metals Ltd gave written notice that they intend to commence Exploration Activities within the Kunjen Olkol determination area pursuant to the Native Title Protection Conditions (NTPCs). Tate Transition Metals Ltd acting as agent for Munuku Pty Ltd which is the authorised holder of the EPMs. This meeting is being facilitated pursuant to cl.4 of the NTPCs.
