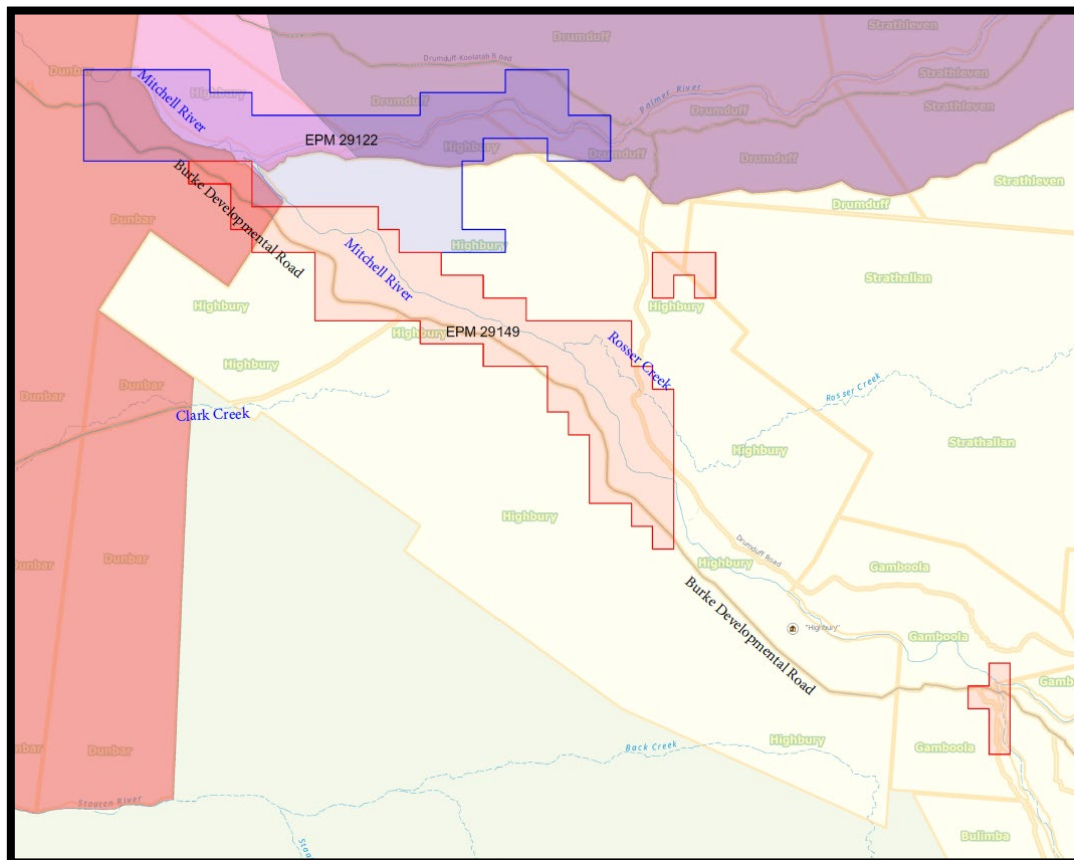
On 27 August 2025, the State of Queensland issued a notification under s.29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying Exploration Permits for Minerals (**EPMs**) 29122 and 29149 as acts that attract the expedited procedure.

This notice is to advise that Cape York Land Council (**CYLC**) will be facilitating a consultation meeting for those Native Title Holders who hold rights and interests in the areas of EPM 29122 and 29149 (as shown on the map **below**) that fall within the Abm Elgoring Ambung Aboriginal Corporation RNTBC, Kunjen Olkol Aboriginal Corporation RNTBC and Kowanyama People Kunjen Olkol and Olkola Aboriginal Corporation RNTBC's. At this meeting, CYLC will discuss the expedited procedure and options available to progress this matter.
