On 25 May 2025, the Department of Resources issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (NTA) identifying that the proposed Exploration Permit for Minerals (EPM) 28929 as an act that attracts the expedited procedure.


This notice is to advise that Cape York Land Council (CYLC) will facilitate a meeting with:
