On 27 April 2026, Ventia Pty Ltd issued a notification under section 24MD(6A) of the *Native Title Act 1993* (Cth), stating that it proposed to undertake maintenance work to repair and rebury the existing exposed conduit by excavating along the existing trench line to bury the conduit at the correct depth.

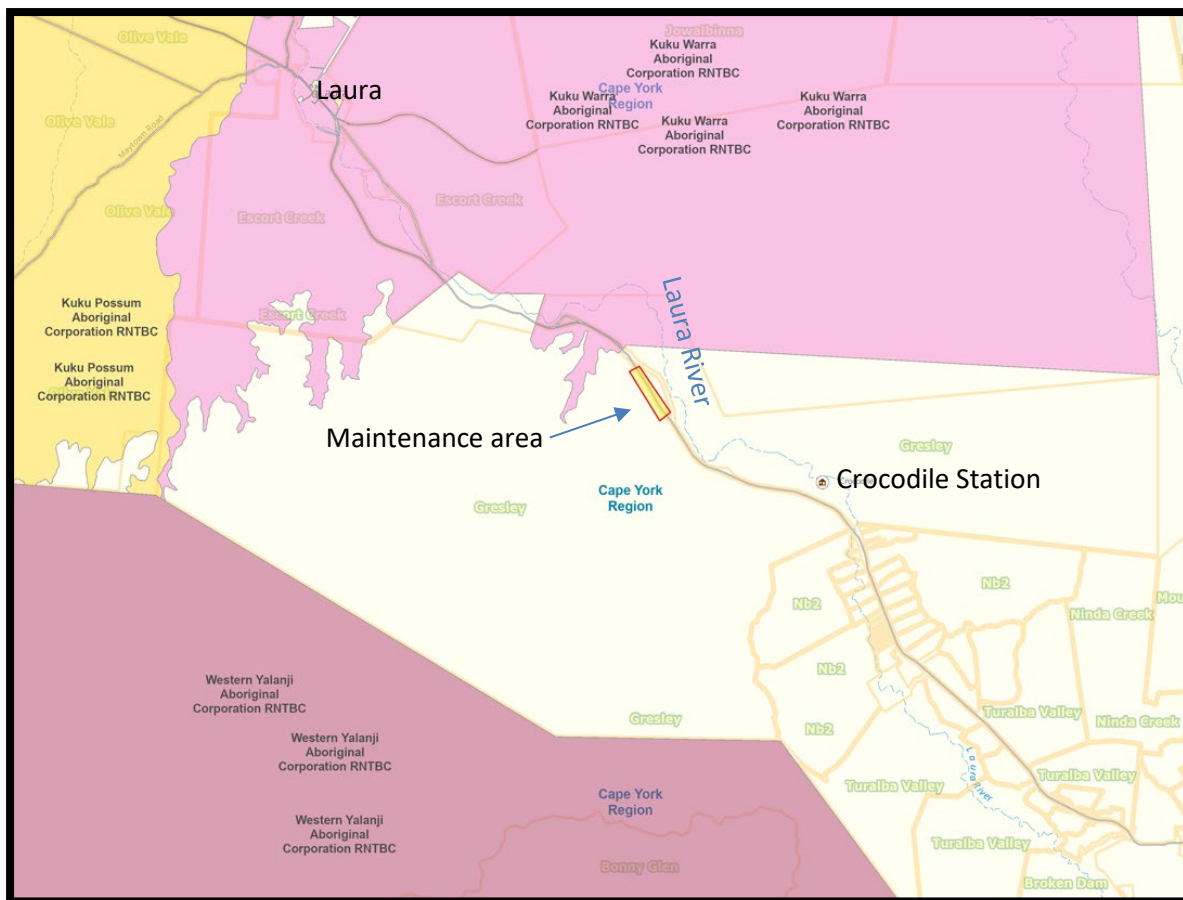
