On 30 June 2026, Chief Justice Mortimer made orders (**30 June Orders**) that, among other things, the above proceedings be heard and determined together. The hearing of evidence in relation to the proceedings will commence on 9 November 2026.

The Court has also ordered that any person, or group of people, who wish to make a claim to sea country over any of the areas the subject of these proceedings must do so by 12 October 2026 (see Order 14 of the 30 June Orders).

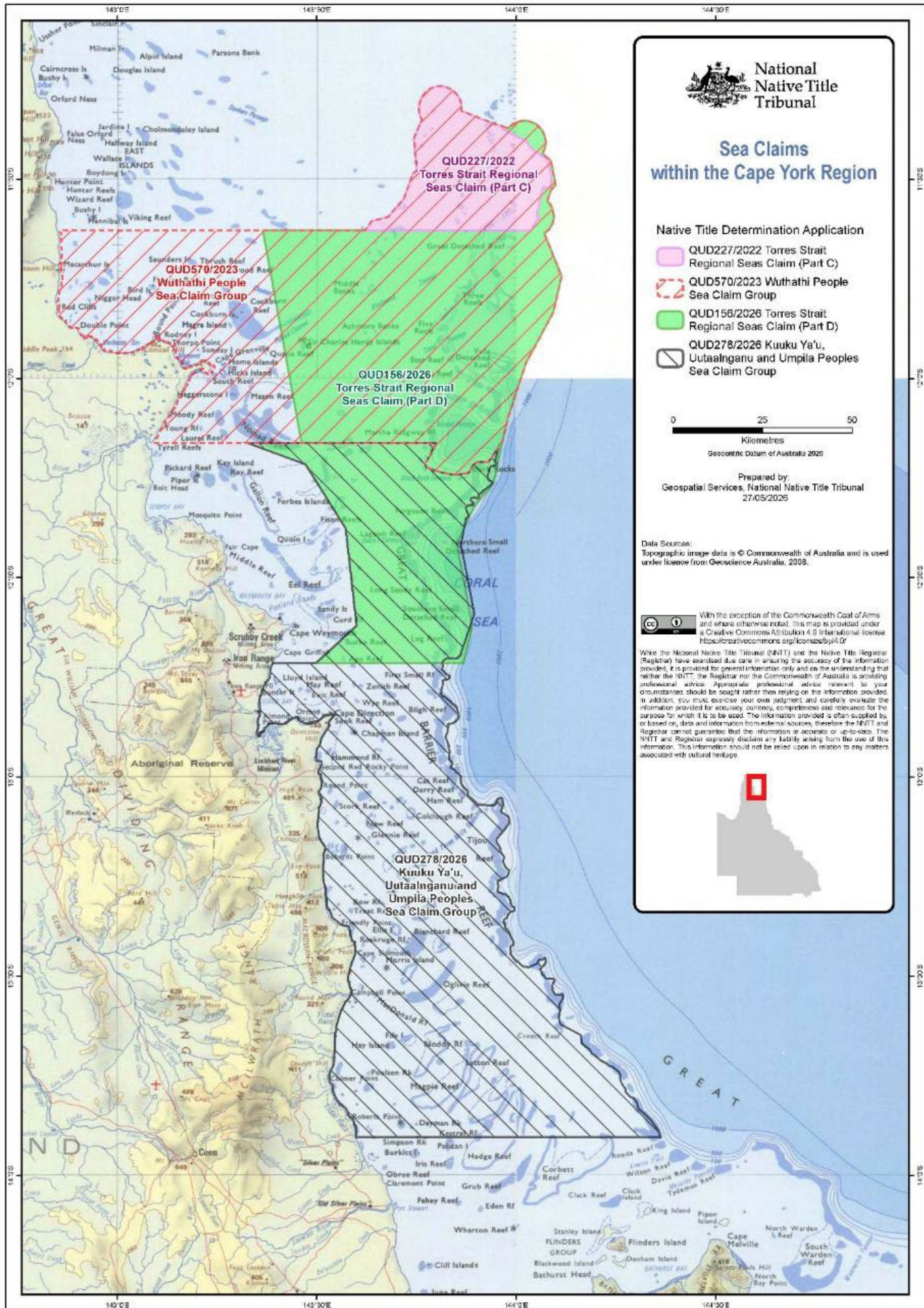

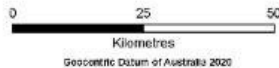
