Cape York United Number 1 Claim (QUD673/2014)

On 15 May 2026, the State of Queensland, represented by the Department of Education, issued a notification under section 24JAA of the *Native Title Act 1993* (Cth) (**NTA**) identifying that it seeks to construct fit-for-purpose staff housing for school teachers employed at Pormpuraaw State School, a public education facility on Lot 60 on SP276847 in Pormpuraaw. The affected lot that faces Korka Street Pormpuraaw is identified in the **map below**.

This notice is to advise that Cape York Land Council (**CYLC**) will facilitate a consultation with the State of Queensland (the 'action body'), pursuant to s.24JAA(14) of the NTA with those people who hold or may hold native title rights and interests within the proposed project area. This meeting will provide an opportunity to discuss the proposed project and its potential impacts on native title rights and interests.
